- Have a registered and trading business for a minimum of 3 years. The following supporting documents are required:
  - o 3 years financial statements.
  - o A valid one-time pin (OPT) / tax pin issued by the South Revenue Services (SARS).
  - o UIF, COIDA, and other applicable industry regulations registrations.
  - The business owner or the company representative must be willing to be away from business for a period of 6 months.
- Minimum annual turnover of R500 000;
- Business owner(s) or directors must possess technical experience relevant to the business, with hands-on experience in the running and management of the business;
- CV of the applicant;
- A business plan or a comprehensive company profile;
- A valid passport (valid not earlier than 28 February 2025);
- Proof of residency in Johannesburg (Statement of Water and Lights, Rates and Taxes) or an affidavit confirming the place of residence;
- Must be proficiency in English and be able to maintain the highest ethical and professional standards as they will be representing the COJ/RSA; and
- Must be willing to undergo a medical check-up and police clearance.
